

Executive Summary

Clay County, Missouri's, labor pool, featuring a population of more than 2.3 million people with approximately 1.2 million workers, is both more educated than the national average and has a population growing faster than the national average.

As compared to other parts of the country, most all of which are struggling to provide quality labor, Clay County's labor market is very strong, here are its strengths:

- A total of 94.6% of the working age population has a high school diploma or higher compared to the national average of 89%. Additionally, 24.6% of residents possess a bachelor's degree, which is 3.4% above the state average.
- Clay County's population has grown by 1.3% since 2015 compared to the US average of 0.7% population growth, and the Clay County labor shed has experienced population growth over the last 5 years as its population has grown by 17,392, an 0.8% increase. In comparison, over the past five years, the U.S. population grew by 0.7% and the County's population increased by 1.3%. As you will see in the chart below, the labor shed's population is projected to continue to grow:



- Very few labor markets in America draw from a population of more than 2 million people. The sheer size of the labor market gives Clay County a unique strength.
- The fastest growing counties within the Kansas City MSA are Clay County to the north and Platte County to the north due to the primary manufacturing plants being located mostly north of Kansas City meaning as population grows to the North of Kansas City, Clay County employers will continue to have access to workers.

- While Clay County has experienced rapid population growth, more than 85,100 people drive out of Clay County daily to work creating a pool of potential workers for new and expanding businesses.
- Clay County has 55% more people employed in manufacturing than the US average with 13,966 new manufacturing jobs having been created since 2015.
- Clay County's largest GDP contributor in 2020 was Manufacturing at \$2,721,004,000.
- Clay County has 133,349 people in its labor force and 108,915 jobs creating an excess labor pool of 24,434 people just within Clay County.
- Among company executives we interviewed in-person who had worked at other facilities in different parts of the USA, we were told the ability to hire and retain workers in Clay County is easier than most other locations where they have worked.
- Clay County's labor force participation rate of 70.1% is 6.9% higher than the USA average.

Next Move Group's consultants interviewed numerous companies, within various business sectors ranging from manufacturing to hospitality, within Clay County to understand both the strengths of the labor force and the geography from which people drive to their facilities in Clay County to work. Additionally, Next Move group reviewed U.S. Census data as well as data from Economic Modeling Specialists International to conduct the research associated with this report.

While Clay County is home to the following major employers: Ford Motor Company, Cerner Corporation, Hallmark Cards, Worlds Of Fun And Oceans Of Fun, Magna, Harrah's, Cook Composites & Polymers, Ameristar Casino, Wagner Logistics, and Regal Plastics Supply, 85,105 people are driving out of Clay County daily to work at other places of employment within our region creating a ready supply of labor of 85,105 people a new company could easily target for its workforce. Clay County has a very strong labor market to support General & Advanced Manufacturing, Entertainment & Recreation, Transportation & Warehousing, and Professional, Scientific, & Technical Services.

Next Move Group found a distinct difference in how employers rated their ability to attract workers based on an hourly rate of \$16/hour. Those above \$16/hour reported very few issues in attracting quality workers. Those below \$16/hour still had the ability to attract quality workers, but they reported it was tougher to do than those who paid more than \$16/hour. Next Move Group ran zip code data for various companies which pay both above and below the \$16/hour threshold to determine what the labor pool is for each:

- For companies paying below \$16/hour they can expect:
 - Total population of this labor shed area is approximately 2,007,100 with a total workforce of 1,061,118

 Based on zip code data we received from various companies within Clay County, employers pull workers for below \$16/hour most often from a radius of Clay County plus 20 miles to the south and west of Clay County



Employers paying \$16/hour and less can expect to draw labor from the region in red with a population of approximately 2 million people

- For companies paying above \$16/hour they can expect:
 - Total population of the labor shed is approximately 2,374,671 with a total workforce of 1,262,620.
 - Based on zip code data we received from various companies within Clay County, employers pull workers for above \$16/hour most often from a radius of Clay County plus 30 miles to the north and east of Clay County and 20 miles to the south and west of Clay County.



Employers paying \$16/hour + can expect to draw labor from the region in blue with a population of 2.3 million people.

Methodology

The following data sources were utilized to develop this study:

Employer Interviews- Major employers were interviewed in-person to determine current labor market satisfaction, trends, opportunities, and challenges.

Employer Zip Code Data- All major employers interviewed for this analysis were asked to provide zip code data for their existing workforce. This data helped us determine the labor draw area at various wages.

JobsEQ by Chmura- This data gave us 5-year growth patterns per occupational code, average wages per occupational code, and a baseline of how Clay County compares to US averages per occupational code.

US Census "On the Map" Data- This data provided us information on the workers commuting out of Clay County daily to work and those commuting into Clay County daily to work.

Employer Online Survey- Employers were surveyed online to gauge satisfaction and opinions concerning the workforce via a 16-question online survey instrument.

Labor Market Quantified

A review of U.S. Census Data, Economic Modeling Specialists International data, and interviews with employers were used to define the geographic area from which employers in Clay County can reasonably expect to draw employees. This labor shed was further defined to show a distinction between the labor pool for workers paid both above and below \$16/hour.


In interviewing businesses and reviewing the zip code data of their workforce, Next Move Group found that companies which offered wages above \$16/hours were typically more likely to pull workers from a larger geographic area. For example, the total population of the below \$16/hour labor shed was approximately 1,975,350. In comparison, total population of the labor shed when adjusting for above \$16/hour is 2,374,671, roughly 399,000 more people.




Note, while employers paying less than \$16/hour will pull from a smaller radius, the population within this radius is still 2.1 million people making it a very strong labor shed area even for the lower paying companies


In addition to Clay County, labor was primarily pulled from the counties of Jackson County, Missouri, and Johnson County, Kansas. Of the regional labor shed population of over 2.3 million people, 242,516 reside in Clay County.

Clay County is a net exporter of workers, meaning new and expanding companies in Clay County have a very good opportunity to attract good workers from people currently living in Clay County who are leaving the county to work. As the map below indicates 85,105 people who live in Clay County leave the County to work on a daily basis. 66,227 people drive into Clay County from outside the county to work on a daily basis and 41,302 people who live in Clay County also work in Clay County. 13,900 more people are leaving Clay County each day to work than are driving into the county to work creating a strong labor pool for employers within Clay County.








Annual Average Projected Job Growth by Training Required for Clay County, Missouri



Industry Cluster in Clay County




Industry Clusters for Clay County, Missouri as of 2020Q4

Cost of Living

The Clay County labor shed area's cost of living is 94.8, 5% below the USA average. This is lower than the average cost of living means that wages go further in Clay County than the national average.


Population Growth

Clay County's labor shed has experienced steady population growth over the last five years. Population has grown by 0.8% since 2015. In comparison, over the past five years, the U.S. population grew by 0.7%, Missouri's population increased by 0.3%, and Clay County's population increased by 1.3%.




Commuting Patterns

According to the US Census Bureau, the average travel time for people who work in Clay County to travel to and from their jobs is 22 minutes. Among primary occupations, Clay County is attracting over 66,227 workers from outside the County into the County to work. Additionally, the County is retaining over 41,302 workers within the County. However, over 85,105 workers are travelling outside of the County to work.

Educational Attainment in Clay County

Educational attainment within the County is a strength in comparison to the state and national averages. A total of 93.8% of the working age population has a high school diploma or higher. In Clay County, 24.6% of residents possess a bachelor's degree, which is 5.9% above the state average and 3.4% above the national average. Additionally, 9.3% hold an associate degree which is also slightly above the state and national average.

Challenges Companies Face in the Workforce

When asked what challenges their company currently faced in Clay County, a few company stakeholders mentioned that finding industrial maintenance people is a challenge. The most common workforce challenge companies mentioned to us was that it is hard to find skilled trades people in general.

Additionally, a company mentioned the need for public transportation to their plant which coincides with their 3 shift-change times.

Several companies mentioned they have had some challenges with applicants not passing drug tests.

Observations from In-Person Interviews of Local Employers

Among company executives we interviewed in-person who had worked at other facilities in different parts of the USA, we were told the ability to hire and retain workers in Clay County is easier than most other locations where they have worked.

It is common practice in Clay County to hire employees on a 3-month temp to hire basis.

Primary Occupation Classifications

A review of Standard Occupational Classifications (SOC) codes is useful to identify the experienced pools of workers within the Clay County labor shed. The SOC is a federal statistical standard which classifies occupations based on worker training and skill sets. If a worker can be classified in two separate occupations, he or she is classified in the one which requires the most advanced skills and training. It is based on the work performed and covers all work that is performed for pay.

The codes themselves are grouped into categories based on industry type. Beyond that into broad categories, and from there into more specific categories. A comparison of SOC codes may give indications of skill sets and training which could be transferrable from one occupation to a different one.

The Location Quotient (LQ) is a comparative measurement that compares the number or percentage of workers in a specific occupation within the labor shed to the national average for concentration of those workers in the national workforce. Nationwide, the LQ of any occupation is 1. An LQ of 10 for a particular occupation within a specific labor shed means that there are 10 times as many of that kind of worker as the national average.
