### Business Attraction

LEDC is tasked with marketing the strengths of the Liberty area to attract new business. Through its attraction efforts, LEDC promotes the assets and advantages of conducting business in Liberty to prospects outside the Liberty area, the community as a whole, and LEDC Investors.

#### Business Retention and Expansion

We are committed to retaining the existing businesses in the Liberty area and facilitating their growth and expansion. LEDC serves a critical role as an ombudsman for the business community to identify tools and resources that encourage and support business growth, thus creating and maintaining a healthy business climate.

### Strengthening the Organization

LEDC must raise its own operating funds, which includes contracting with public entities for economic development services, as well as soliciting investment dollars from private sector partners. This provides an opportunity to identify operational improvements and demonstrate the impact and achievements LEDC has each year with a constant focus on effectiveness.

## Letter From the Chair

Greetings from the Board of Directors of the Liberty Economic Development Corporation. As 2022 comes to a close, we would like to provide a look back on the economic growth that has happened in Liberty throughout the past year.

It has been an exciting year for Liberty! Liberty has welcomed Amazon and Walgreens while Hallmark, Ford Stamping, and Scarbrough have expanded their operations. The LEDC is proud to be a part of the economic development process, to lead discussions and market Liberty as a great place to live, work and play. We are expecting more announcements in 2023!

We are pleased to report that our community has under construction or completed construction on about 7 million square feet of industrial space this past year with another 5 million square feet planned. Many thanks to all of the stakeholders, developers, brokers, companies, and investors who have made this happen! Quite simply, Liberty is now able to compete more effectively for prospective company investments.

Another strategic priority for the LEDC over the year has been an emphasis on workforce development. With the financial support from the City of Liberty, Ford, LMV, Evergy, Spire, and Ameren. LEDC hired IDM Consulting to conduct a workforce strategic plan that will be completed by the end of 2022 with implementation starting in 2023. LEDC's goal is to implement the plan, engage stakeholders, and work on strategies to help Liberty companies fill existing openings as a result of the new jobs being created.

LEDC also supports entrepreneurship. LINK Business Facilitation initiative was launched in November 2020. Jolinda has worked with over 50 companies, creating over 50 new jobs and \$500,000 in new investments. She has also become a central point of contact for entrepreneurs that want to talk with someone confidentially about how to grow their business.

Please enjoy the annual report and the community growth and pride it represents. If you are currently a partner, thank you for your support and investment. If you are not a partner, I invite you to become involved, and learn more about how we can work together on continued economic growth in Liberty and the rising tides that help raise all ships!

- Affiliations with MU Health Care for orthopedic surgeons, Saint Luke's Cancer Institute, and Children's Mercy In addition, the hospital is a Level II Trauma Center and holds:
- Three consecutive A grades in patient safety from Leapfrog Group
- Level II Time Critical Diagnosis state designation in trauma, stroke, and heart attack
- Top Performer status in the 2022 Healthcare Equality Index one of only 251 hospitals nationwide to receive this designation which evaluates our equitable and inclusive care for LGBTQ+ patients and their families.

Liberty Hospital is a public hospital and is a political subdivision district hospital under Chapter 206 of the Revised Statutes of Missouri. It is governed by a six-member, publicly elected board of trustees who serve six-year terms. For more information visit libertyhospital.org.

• Ford announces 6,200 new UAW jobs in the Midwest; converting nearly 3,000 temporary employees to full-time; upgrading plants to deliver Ford+ EV, ice product plans.



• Past Chairman Jim Rucker presented David Feess, former CEO of Liberty Hospital, with an award congratulating him on his retirement and thanking him for his service as the 2021-2022 LEDC Chairman.





• Walgreens, a leader in retail and wholesale pharmacy opened its new \$30 million high-tech fulfillment center in the Liberty Commerce Center Industrial Park.





• Scarbrough Warehousing expanded its Kansas Cityarea operations footprint by taking over an additional 190,000 square feet at Liberty Logistics Park. After just eight months of operation, Scarbrough Warehousing's 226,000-square-foot facility in Liberty, MO, is operating near peak capacity. The e-commerce surge and import boom have spiked demand for fulfillment and distribution warehouses nationwide. Scarbrough has signed a lease to acquire an adjoining warehouse space to keep up with projected growth. The takeover will grow its local footprint by 84 percent for a total of 416,000 square feet.













• September Investor Event with Jewell Unlimited. Conner Hazelrigg and Glen Martin presented on Jewell Unlimited which was founded in 2021 by William Jewell College. Jewell Unlimited is a Learning Agency that delivers focused development and growth solutions to a variety of learners utilizing multiple methods.



• In October, Liberty EDC Investors and Liberty area entrepreneurs and small business owners were invited to the Woodneath Library Center Auditorium. Anne Wallace, Square One Director, and Kelly Head, Business Librarian, shared ways Square One for Small Business helps businesses grow.
