



2023 RIBBON CUTTINGS



• In June Hallmark celebrated the opening of their 850,000 sq. ft. Liberty II distribution center in Liberty off Shepherd Road with a ceremonial ribbon cutting. The Liberty II facility is an expansion of the current Liberty Distribution Center which has been in Liberty for over 50 years. With this expansion Hallmark anticipates more than 1,400 full-time employees working between the two facilities and about 150 seasonal part-time employees. Expanding the Liberty campus honors Hallmark's commitment to sustainability by reducing transportation needs and using an estimated one million fewer cardboard boxes annually for outbound shipping. Liberty Hospital announces intent to partner with The University of Kansas Health System



• After an eight-month search in 2023 for a health system partner, Liberty Hospital announced its intent to pursue a partnership with The University of Kansas Health System. Leaders at both organizations have signed and executed a non-binding Letter of Intent (LOI) to partner. The signing of the LOI also marks the start of the final phase of due diligence and partnership planning between our organizations. The hospitals expect to complete the work and announce the details of the final agreement early in 2024 around the time of Liberty Hospital's 50th anniversary. It is already abundantly clear that the benefits of this partnership will be numerous and far-reaching for the patients, staff, providers and Northland communities. As part of The University of Kansas Health System, Liberty Hospital and clinics will be at the forefront of today's healthcare needs, and we will continue our significant contributions to the local economy and community.
